General References

Age Categories

All ages are 4-H Age (before January 1st of the current year)

Juniors: 4-H ages 7-9

Intermediates: 4-H ages 10-13

Seniors: 4-H ages 14-18

Cloverbuds: 4-H ages 5-6 (only able to participate in Show and Share event).

Dogs and Other Animals

Contact your agent at least 2 weeks before the event if you plan to bring an animal. Owners must provide adequate kennels or cages for their animals. During the presentation, animals should be on a carpet square, towel, rug, or other covering.

No dogs in season are allowed to participate in shows.

Animals larger than dogs are not permitted in the building. Work with your county agent to see if an outdoor demonstration is possible.

Facility Rules and Legal Considerations

No explosives, rocketry engines, volatile substances, firearms, weapons, or straw allowed.

Goals & Purpose

Regional 4-H Presentation Day

- 1. Demonstrate the benefits and opportunities provided through 4-H by showcasing the 4-H members themselves.
- 2. Give 4-H members an opportunity to learn skills and gain confidence in their abilities to exercise parliamentary procedure, speak effectively, and give creative performances in the arts.
- 3. Place special emphasis on core 4-H skills such as parliamentary skills and oral presentations.
- 4. Give 4-H members an opportunity to participate as an individual, as part of a small group or team, and as part of a large group or club.
- 5. Recognize 4-H members and help them grow their skills by measuring all performances against a published standard of excellence (Danish system).
- 6. Recognize as many top performers from the County 4-H Days as possible by providing for further competition in a multi-county 4-H environment to acknowledge their achievements (American system).

Each category of events and each individual event also has specific goals and purposes.

Categories of Events

Parliamentary Presentations

The primary purpose of parliamentary presentations is to further the knowledge of parliamentary procedure – a core purpose relatively unique to 4-H – to help 4-H members lead and participate in effective meetings and be prepared to further understand how our American system of government functions.

Events in this category are Model Meetings and Gavel Games.

Public Presentations

The primary purpose of public presentations is to further public speaking skills – a core purpose of 4-H – so that 4-H members may learn to communicate effectively with an audience. The focus is on oral presentation skills, not on performance or staging skills. Participants may be working to develop skills in effective persuasion or just be enthusiastic about sharing their interests with others. Public presentations may include talks that *show how* (Demonstration), *tell how* (Illustrated Talk), *tell about* (Project Talk), *persuade* (Public Speaking), *share* (Show and Share), or *interpret* (Oral Interpretation and Historical Speech).

Events in this category are Demonstrations and Illustrated Talks, Project Talks, Public Speaking, Digital Media Presentations, Impromptu Speech, Poetry & Prose, Show and Share, Historical Speech, and Career Exploration.

Talent Presentations

The primary purpose of talent presentations is to further 4-H members' confidence in working in front of an audience and to encourage the growth of skills in the performing arts. This category encompasses musical, dramatic, and dance skills with a focus on performance skills including piece selection, performing, staging, and costuming.

Events in this category are Instrumental Solos, Piano Solos, Instrumental Ensembles, Vocal Solos, Vocal Ensembles, Solo Dance, Dance Groups, One-act Plays, Solo or Duo Acting, Skits, Solo or Duo Novelty, and Group Novelty.

Recognition & Judging Models

Recognition

4-H members should be recognized for their participation by providing ribbons to all participants and awarding those ribbons by comparing the performance against the published standard of excellence (Danish System).

A pre-selected number of top performers in each County 4-H Day event should be further recognized by designating their performances as Top Purple/Blue or Alternate Top Purple/Blue. Top Purple/Blue participants are allowed to participate in Regional 4-H Day with the Alternate Top Purple/Blue Participants being offered this opportunity if the Top Purple performer is unavailable.

The Danish system of judging is a method of evaluation where an exhibit or process is evaluated against a set of standards, and recognition is awarded on the degree to which the standard has been met by each 4-H member. The standards of excellence are often printed on a judge's scorecard and allow for the performance to be judged on one's own merit, and not in comparison with others in the class.

The following ribbons apply:

WHITE: Fair, denotes much improvement needed. Fails to meet minimum standards.

RED: Good, some improvements needed. Meets minimum standards.

BLUE: Excellent, minor improvements needed. Exceeds minimum standards.

PURPLE: Superior, outstanding on all standards.

No Top Purples will be awarded on Regional 4-H Day. However, up to three Judge's Choice Awards may be awarded per event and age level.

Judges' decisions are final.

Judging Model

The main job of judges is to help participants grow their skills. This is best accomplished when judges write comments that are both encouraging and accurately. The score sheets for each event allow judges to see the criteria for the event and to comment based on those criteria.

Comments should be encouraging, sensitive, and specific. Telling a participant with poor eye contact that his/her eye contact is good is not helpful, nor is overly harsh criticism that doesn't acknowledge the skill level the participant has achieved.

Demonstration/Illustrated Talk

A Demonstration is:

- ✓ Show (not tell) how
- ✓ Make or do something often ending with a finished product

An Illustrated talk:

- ✓ Tell (not show) How
- ✓ Tell about doing something with no finished product.

- 4. The judge will serve as timekeeper.
- 5. **No digital media presentation allowed**. They should be entered under the Digital Media Presentations.
- 6. Topics, visuals, props, language, and attire should be family-friendly and not violate the Kansas 4-H Code of Conduct.
- 7. Judge will deduct one ribbon placing if time is exceeded by more than 30 seconds.

- 4. Prep time arrangements will be left to the County/District at their competitions. Regional 4-H Presentation Day Prep Time will be done in the room with the judge.
- 5. No outside resources may be brought into the prep area.
- 6. The 4-H member must speak about the topic selected and clearly state the topic in the speech's introduction.
- 7. You must present your presentation in person.
- 8. The judge will serve as the timekeeper.
- 9. Topics, visuals, props, language, and attire should be family-friendly and not violate the Kansas 4-H Code of Conduct.
- 10. Judge will deduct one ribbon placing if time is exceeded by more than 30 seconds.

Poetry & Prose (Formerly Oral Interpretation)

✓ Reading an excerpt from a book or written work using voices, gestures, facial expressions, narrations, and other means of creating a dramatic storytelling.

- 1. The age of the oldest member determines the competition age group. Example: A 9 & 11-year-old presenting together would be in the 10-13 age group.
- 2. Participants select all or a portion of a piece of literature (books, poetry, etc.). The selection can be published material or the participant's own work.
- 3. The title and author of the selection should be introduced during the presentation.
- 4. A short section may be added to the presentation to explain the context of the selection, particularly if it is taken from a longer work.
- 5. No props, audiovisuals, or costumes allowed.
- 6. Hands must not touch the floor, and one foot must remain on the floor at all times.
- 7. The entire presentation must abide by all copyright laws. All images and music must be cited correctly.
- 8. You must present your presentation in person. Presentation does not have to be memorized.
- 9. The judge will serve as timekeeper.
- 10. Topics, visuals, props, language, and attire should be family-friendly and not violate the Kansas 4-H Code of Conduct.
- 11. Judge will deduct one ribbon placing if time is exceeded by more than 30 seconds.

Historical Speech

A Historical Speech is:

✓ Presenting a speech originally given by a historical figure.

- 1. Participants select all or a portion of a one speech previously given by someone else in a historical setting, such as Washington's Inaugural Address, Lincoln's Gettysburg Address, Sojourner Truth's "Ain't I a Woman" Speech, Reagan's "Tear Down This Wall" Speech.
- 2. The original speaker and the setting for the selection should be introduced during the presentation.
- 3. A short section may be added to the presentation to explain the background and historical context of the selection.
- 4. 4-H members are encouraged to dress in the time period and manner of the original speaker or audience. This is optional.
- 5. No props, or audiovisuals allowed.
- 6. Hands must not touch the floor, and one foot must remain on the floor at all times.
- 7. The entire presentation must abide by all copyright laws. All images and music must be cited correctly.
- 8. You must present your presentation in person.
- 9. The judge will serve as timekeeper.
- 10. Topics, visuals, props, language, and attire should be family-friendly and not violate the Kansas 4-H Code of Conduct.
- 11. Judge will deduct one ribbon placing if time is exceeded by more than 30 seconds.

Career Exploration Presentation

A Career Exploration is:

- ✓ Researching a career that is new to you.
- ✓ A presentation about that career.

Participants need to bring:

- Original copy of the music provided to the judge with measures numbered and your name on your music.
- Participants must furnish their own sound equipment and personnel to play the accompaniment.

- 1. All 4-H members must have an original copy of music for the judge. Original music may be proven by original copy or proof of purchase from the internet or copy of music with letter of permission to use. Failure to present original copy of music to judge will result in lowering the placing by one ribbon.
- 2. You must present your presentation in person.
- 3. Participants should pick up their music after the results are announced.
- 4. Accompaniment is optional.
- 5. Recorded music for accompaniment is allowed in all music divisions. Accompanists do not have to be 4-H members.
- 6. Contestants may only enter the Instrumental Solo division one time.
- 7. Topics, visuals, props, language, and attire should be family-friendly and not violate the Kansas 4-H Code of Conduct.
- 8. Participant will perform only one number.
- 9. Number does not need to be memorized.
- 10. Many 4-H judges prefer unaccompanied instrumental solos

<u>Instrumental Ensemble (Formerly Instrumental Ensembles, Bands, & Orchestras)</u>

Instrumental Ensemble is:

✓ An instrumental performance by two or more individuals showcasing two music selection.

Equipment Provided:

- A piano **OR** electric keyboard **may** be available for accompanists.
- Music stands will be provided.
- Some counties/districts may provide a practice room but not all facilities will be able to provide this. A piano will not be provided in the practice room.

Participants need to bring:

- Original copy of the music provided to the judge with measures numbered and your name written on your music. If a large group, conductor's score original should be given to judge.
- Participants must furnish their own sound equipment and personnel to play the accompaniment.

- 1. Group may be composed of 2 or more 4-H members, not including the accompanist. (Cloverbuds cannot perform in this category.)

- 1. The group may be composed of any number of 4-H members and leaders. Cloverbuds may not participate in the Model Meeting. The presentation should give the impression of an actual 4-H meeting. Look at and talk to 4- Hers, not to the audience watching the presentation. All members are expected to participate in the meeting.
- 2. An agenda of the Model Meeting must be presented to the judge before the meeting is called
 - a. to order. The agenda should include the following as spelled out on the judging score sheet with suggested time frames:
 - b. Opening ceremony and business meeting 12 to 14 minutes
 - c. Program 14 to 16 minutes
 - d. Recreation 4 to 5 minutes
 - e. Closing ceremony and announcements 2 minutes
- 3. The meeting may include a ceremony, which would be incorporated into the time frames above.
- 4. During the Model Meeting, the secretary should take notes. After the meeting, the secretary must turn in the Model Meeting notes and the up-to-date secretary's book. If more than one club is represented in the group, only one secretary's book of the Model Meeting secretary needs to be presented to the judge.
- 5. Recreation may be at any time during the meeting.
- 6. The club determines which officers sit up front during the meeting.
- 7. The performer should recognize this as a family event and choose costumes, themes, and performances that show respect for the performers and the audience.

Rules:

- 1. Teams will have four or five participants who assume the following roles:
 - a. President, Vice-President (program chairman), Secretary, Treasurer
 - b. If there is a fifth participant, that person will serve as a club member.
- 2. The age of the oldest member determines the age group of competition.
- 3. Topics, visuals, language, and attire should be family-friendly and not violate the Kansas 4-H Code of Conduct. All participants will be judged on their presentations.
- 4. The presentation time should be balanced among participants as much as possible.
- 5. Each participant will take a written test and the total of the top four test scores will count toward the final score.
 - a. Test will be age appropriate
- 6. Test Bank questions are located starting on page 8, below are the following age group break down number of questions.
 - a. Juniors: 5 multiple choice, 5 True and False, 5 matching questions (30 points total each question is worth 2 points)
 - b. Intermediate: 7 multiple choice, 13 true and false, 10 matching (total of 30 questions worth 30 points)
 - c. Seniors: 9 multiple choice, 6 true and false, 15 matching-- (total of 30 questions worth 30 points)
- 7. The general outline of the presentation should follow the Gavel Games Agenda, which can be found in the page 6.
- 8. The presentation will be scored according to the Gavel Games Score Sheet, which can be found in the Regional Club Day Guide
- 9. The only items that can be used during the oral presentation are previously listed as equipment provided by the team and/or event monitors.
- 10. The team has five minutes before the 25-minute presentation time to share information on how to do motions and annotate agenda and parliamentary procedure sheets with helpful notes. Each member of the team will be expected to participate during all parts of the presentation.
- 11. Teams will draw for a topic and base their presentations and motions around that topic.
 - a. Just before each team begins their planning time at the beginning of their presentation, one team member should draw three topics.
 - b. The team is allowed to consider all three of the topics during their planning time.
 - c. Prior to beginning their presentation, the team should return the topics to the judge(s), indicating which topic they have selected for their presentation.
 - d. The unused topics are returned to the pool for other teams to draw from. The selected topic is not returned to the drawing pool.
 - e. There must be at least two more topics in the pool than the total number of teams participating to allow the final team to have a selection. If possible, try to have four more topics in the pool to ensure the final team has equal opportunities to draw from a variety of topics.
- 12. Junior teams will be scored for only their first ten parliamentary procedures. Intermediate teams will be scored for the first fifteen procedures. Senior teams will be scored for the first twenty procedures.
